
Inland Empire Branch 038 is still providing Zoom capabilities, *in addition to meeting locally*, in the first two months of each quarter.

## 2023 NW Region Convention Recap

The **2023 Northwest Region Convention** was held August 18-19, 2023, at the Holiday Inn, 16345 Merchant Way, Nampa, ID 83687.

One major change was made to the NW Region By-Laws: The PCT dues for each member in good standing of each Northwest Region Branch is increasing to 50 cents next year (an increase of 15 cents). We are awaiting the ratification of this change by the NBOD at the 2023 National Convention.

**The 2024 Northwest Regional Convention will be held on September 6-7, 2024, at the Clover Island Inn located in Kennewick, Washington.** It is being held later than normal since the 2024 National Convention won't be held until November to coincide with the FRA 100 year Celebration.
