FRA Master of Ceremonies (MC) PRPNW Roger Christopher and Auxiliary Master of Ceremonies (LAFRA MC) Jena Shadwick called the Joint Opening of the Northwest Regional Convention to order at 0900 on 19 August 2023 at the Holiday Inn Express, Nampa, Idaho.

FRA MC Roger Christopher then directed the Master-at-Arms (MAA) to invite shipmates and ladies to enter the meeting hall and close the doors. This was completed and the MAA announced that the shipmates and ladies were in the hall.

FRA MC Roger Christopher asked that everyone remain standing for the introduction of guests and national officer.

MAA stated that Keith Millar, from the Rescue Mission, desires admission to the meeting Room. FRA MC Roger Christopher asked the MAA to retire and re-enter the meeting to present Mr. Millar at the Altar. Then he requested him to escort Mr. Millar to his right and have him seated.

MAA stated that NP James Robbins, Branch 126, desires admission to the meeting room. FRA MC Roger Christopher asked the MAA to retire and re-enter the meeting to present NP Robbins to the Alter. Then he requested him to escort NP Robbins to his right and have him seated.

FRA MC Roger Christopher then introduced the first guest speaker:

Please welcome Keith Millar, Veterans’ Ministry Program Manager of the Boise Rescue Mission Ministries.

He grew up in Montana and moved to Nampa, Idaho, for college. He joined the Idaho Army National Guard when he was 18 to pay for school. Keith retired from the Idaho Army National Guard in November 2020 as a Sergeant First Class (SFC/E7). During his time in the military, he went on several humanitarian missions, including spending 30 days in 2005 in New Orleans after Hurricane Katrina. Keith also deployed to Baghdad, Iraq, from 2010 to 2011 to support Operation New Dawn.

He is the Veterans Ministry Program Manager for the Boise Rescue Mission Ministries. He works with Vets who experiencing homelessness. The Veterans Ministry Program’s mission is to find housing for Veterans while addressing the reasons for becoming homeless in the first place. There are 4000 homeless people in the Ontario, Oregon, to Mountain Home, Idaho area.

Keith and his beautiful wife, Robyn, celebrated 27 years of marriage in June. They have two children. Patrick, 23, is in the Idaho Air National Guard, and works full-time for Autovol in Nampa. Kendra, 17, is a Senior at the Elevate Academy in Caldwell.

He is currently also an area recruiting officer with the USN Sea Cadet Program and Jr NROTC as a LCDR in the Program.

FRA MC Roger Christopher and Auxiliary MC Jena Shadwick announced to Shipmate NWR President Rex Faubion and Auxiliary NWR President Rose Hall that they were ready to turn the gavels over to them. This was done and the convention was declared convened.

Shipmate President Rex Faubion stated that "you have heard the first credentials report. It has been moved and seconded to receive the report." A vote was held and the motion was carried.

Shipmate President Rex Faubion said they would proceed with our Officer Reports and gave his first..

It has been an honor and privilege to serve as Northwest Region President 2022-2023. My path to this office was at the prompting from PNP Marvin 'John' Johnson who advised and assured that he would be there to show me the in and outs. Sadly, the day I was elected as the Regions President was the day John passed. We can't control the loss of Shipmates but we can make certain that what they fought for is preserved. I've never talked with members at meetings without addressing the need for recruiting and retaining the members we have on the rolls. Make sure you are doing your part.

As I stated I was elected as the Northwest Region President on 20 August 2022 at our Region Convention in Spokane, Washington and installed at the 94th National Convention in Birmingham, Alabama.

During the past year I have had the opportunity to visit various Branches within the NW Region and found that a majority are struggling with getting active participation from their membership. The members are on the rolls but choose not to participate. The importance of communicating with all members, not just the few that show up at meetings cannot be over emphasized. This year has been a learning experience. Visits with Branches have been in person, via zoom, or teleconference. Out Conus Branches in Alaska, Japan and Guam have been contacts via phone only. Contacts with Branches in the Philippines has been through email only.

The Northwest Region has several Branches that are close to surrendering their Charter. Small Branches that are basically aging out.

- Attended monthly community Service Clubs meetings. Active participants are Kiwanis, Rotary, Lions, Masons, American Legion, Fleet Reserve and VFW. Sharing ideas and working together.
- Attended six funerals/memorial services for Shipmates and Veterans.
- Participated in NBOD Zoom meeting on 22 FEB 2023.
- Attended NBOD meeting in Arlington, Virginia 11-16 APR 2023.
- Participated with the Scouts in placing over 1000 Flags on Veterans graves at a local cemetery.
- Participated in Memorial Day Remembrance sponsored by City of Puyallup and Veteran Service Organizations offering 'Two Bell Ceremony' as part of the program.
- Participated in Zoom meetings with PRPWC, RPWC and RPSW discussing the merge/realignment/combining of Regions.
- Participated in NBOD Zoom meeting on 17 JUL 2023 to appoint successor to NED position to fill unexpired term of office.
- Attended Budget and Finance Zoom meetings.
- Attended Membership and Retention Zoom meetings.
- Set up and staff recruiting and information booth for Fleet Reserve Association at the Washington State Fair. This is the 10th year setting up and manning a booth at the State Fair.

- Chairman of Americanism/Patriotism Committee for NW Region.
- Post Commander of R. Vernon Hill Memorial Post 67, American Legion.

The person that holds the Northwest Region together is PRPNW Margret 'Peg' Burke. She has served the FRA and the Northwest Region in the capacity as Region President and currently serves as the Region Secretary/Treasurer. Thank you for your devotion to the Region and the Fleet Reserve Association.

Thank you to all the Shipmates in the Region that have been responsive to questions and calls for recommendations.

I ask for your continued support as we venture into the next year and head toward the Centennial of the Fleet Reserve Association.

Shipmate President Rex Faubion called the FRA 2nd Business Session to order at 1330 and asked the MAA to please invite the Shipmates to enter the hall and close the doors.

MAA stated the Shipmates are in the hall and the doors are closed.

Shipmate President Rex Faubion asked that everyone turn off or silence their cell phones. Thank you.

Shipmate President Rex Faubion asked the Convention Chaplain Chuck Crooks to open the Bible.

Convention Chaplain Chuck Crooks stated the Bible is open.

Shipmate President Rex Faubion called for the second Credentials Report.

Credentials Chair Anna Martin stated there were no changes to the Credentials Report.

Jr Past Regional President Michelle Davis announced that she was in the Uniform of the Day.

Shipmate President Rex Faubion stated that we would continue with the Officers Reports.

NW Regional Secretary/Treasurer Peg Burke presented her report:

This year we have PCT payments from all branches in our Region. We are having success with a new method of payment, i.e. electronic deposit via our Chase Bank App. They email me a copy of the front and back of their check. This procedure is used by our Pacific Branches to pay dues in the future if they don't want to send it by USPS, which can be iffy at best. We even had a CONUS branch "Text" me the pictures of their check and I was able to send them to my email and download them that way.

Each Branch President, Secretary, and Treasurer, if the Branch has the position separated, in the Region is sent an email with their PCT letter attached informing them of the amount of PCT dues to be paid to the Region. We will only use USPS (snail mail) when a Branch has no Officer that has an email address.

Calendar Year 2023 is the first year into our new fiscal year change to the calendar year dates of January 1 through December 31. The end of December 2022 was when the short year IRS 990 was submitted. It will be a full calendar year on the upcoming IRS 990 submission and continuing on.

The Edward Jones Investment lost a few dollars, between \$1500-\$1700, during the past year, but it is slowly getting back to our original investment of \$10,000. As of the end of July 2023 we were less than a \$1000 from our original investment. The Market has wreaked havoc on everyone's investments.

The Northwest Region has as of July 31, 2023, has the following in funds:

Checking: **\$ 5,793.31**

Savings: **\$ 5,466.51**

Took \$3,337.56 from Savings and added it to the CD when it came due in April 2023.

Certificate of Deposit (CD) **\$10,108.70**

Since April 2023 we have earned \$109.03 interest on the CD which has a .05% interest rate vs .015%.

Edward Jones Investments **\$ 9,037.51**

*A loss of **\$952.49** since established.*

Total in bank accounts: **\$30,406.03**

Note: Of the \$30,406.03, please note that **\$4,496.09 is for Essay Contest funds**. That leaves \$25,909.94 in our operating cash fund.

NW Region Budget Committee Chair PRPNW Flanik gave his report. The Audit of the Northwest Region Financials was completed August 12, 2023, and found to be in order.

NW Region Membership & Retention Committee

There was no formal report received from the Northwest Regional Chair.

The Northwest Region did have a nominee for the Frank J. McPherson Memorial Award that will be forwarded to the FRA National Membership Committee for consideration. Their nominee is PRPNW Margret "Peg" Burke.

NW Region Americanism-Patriotism Committee Chair Shipmate Rex Faubion, Branch 104, gave the following report.

The theme of this year's contest: "What the U.S. Flag Means to Me."

Seven branches submitted reports with three (3) of those marked as negative reports. A total of eighty (80) essays were judged at the branch level. Out of the eighty (80) fifteen (15) were received at the region for judging. Results of the region awards are attached to this report. First place awardees were forwarded to national and the NW Region had two students place second in their respective grades. National results are attached.

Branch 063 did very well in getting the word out in their schools. In their interim report they stated that branch members had contacted 50 schools. Most of us have a difficult time getting into the school systems. Well done, but I did not receive an A/P report from them.

NW Region Disaster Relief Committee Chair Mike Batnick did not submit a report this year.

NW Region Time and Place Chair PRPNW Hall stated that the Northwest Regional Convention for 2024 is scheduled as follows:

2024 Northwest Regional Convention will be coordinated by Inland Empire Branch 38, Spokane, WA, on September 6-7, 2024, at the Clover Island Inn, Kennewick, WA at the rate of \$114 per night plus taxes and fees. This site is on the Columbia River between the two bridges over the river In the Tri-Cities area of Washington. Across the street from the hotel is the Coast Guard detachment that monitors the activity on the great Columbia River. All branches from the Northwest Region will be assigned different duties/activities to assist in this endeavor.

Seattle Branch 18 has expressed interest in hosting the regional convention in 2025.

NW Regional Chaplain Bill Hall presented his report.

During this past year I have sent 32 cards:

The only expense to the region is postage stamps. All other product was donated. Thank you for allowing me to assist you in this portion of your term as Regional President.

NW Region C&BL Committee Chair Peg Burke presented the C&BL report.

The changes to the Northwest Region's C&BL were ratified by the FRA NBOD in February 2022 and a copy of the revised Regional C&BL was distributed to all Northwest Region Branches on March 10, 2023. The current version of the NWR C&BL is from the Regional Convention 2022. If you have an older version and do not have the 2022 Version, please contact me and I will email you one.

I have established a “working copy” of the C&BL keep track of changes, i.e. a branch turning in its charter, the passing of advisory board members, etc. If there are any changes made to the C&BL during this convention, they will be noted and entered in it for the next printed revision.

NW Region Legislative Chair, Jerry Fugich did not submit a report for the convention this year.

UNFINISHED AND DEFERRED BUSINESS

The 2023 FRA/LAFRA National Conventions will be September 23-30, 2023, at the Nugget Casino Resort, Sparks, Nevada. See the Northwest Region’s website for all the newsletters.

NEW BUSINESS

The Budget, Finance, and Audit Committee Resolution: The following resolution was submitted by the committee to modify the *NW Region C&BL Standing Rule 4(a)* to read:

“Each Branch of the Northwest Region shall pay to the Regional Secretary/Treasurer the sum of fifty cents (\$.50) for each member on the rolls of the branch in good standing on 31 March of each year. Payment is to be made prior to 31 July of each year.”

Discussion was held and the motion to change this Standing Rule was made. **This resolution was APPROVED by the delegates at the 2023 Northwest Regional Convention to be effective in Calendar year 2024.** The Northwest Regional C&BL Chair was instructed to prepare the C&BL modification and submit it to the FRA National Parliamentarian prior to the 2023 National Convention NBOD Pre-Board meeting next month for ratification.

Convention Silent Auction Division – At the 2022 NW Regional Convention the adoption of the current division was made.

- 50% of the proceeds to go to the FRA NW Region
- 25% of the proceeds to go to the LAFRA NW Region
- 25% of the proceeds to go to the Branch hosting the convention.

This division will be the standard to follow in future Northwest Regional Conventions.

A proposed modification to this division was made with two versions, of which the second proposal (listed below) was adopted to read as follows:

Division of the FRA NW Region’s Convention Silent Auction to split the proceeds in the following manner:

- 50% of the proceeds to go to the LAFRA NW Region
- 25% of the proceeds to go to the FRA NW Region
- 25% of the proceeds to go to the Unit hosting the convention, or if no Unit hosts, to defray the costs of the convention.

This division will be the standard to follow in future Northwest Regional Conventions.

Election of Officers for 2023-2024

Shipmate President Rex Faubion announced that we now have the business of electing our 2023-2024 Regional Officers. Nominations were held and the following were nominated as shown.

PRPNC Maria Behm who is also campaigning for the National Vice President position for 2023-2024 spoke on VSO development, transparency, and work on what we, as an organization, started.

Everyone in the meeting room was given a chance to speak on any subject they had an interest in. Bringing in the younger generations was covered extensively.

Shipmate President Rex Faubion then declared a recess at until 1700, at which time Installation of Officers will be held. Convention Chaplain Chuck Crooks was requested to close the Bible.

Shipmate President Rex Faubion called the FRA Business Meeting to order at 1700 and requested the MAA to invite the Shipmates to enter the hall and close the doors.

MAA announced the Shipmates are in the hall and the doors are closed.

Shipmate President Rex Faubion requested Convention Chaplain Chuck Crooks to please open the Bible. Convention Chaplain Chuck Crooks did so and replied that the Bible is open.
